WHEREAS, Luz Coquia retired on March 29, 2024, after more than 37 years of exemplary public service in the County of Santa Clara; and

WHEREAS, Luz started with the County in 1986 as a Clerk Typist in County Communications at the County's General Services Agency; and

WHEREAS, Luz transferred to the Public Health Department in 1990 as a Clerk Typist, Secretary, Clerical Supervisor, and Office Manager; and

WHEREAS, Luz transferred to the Santa Clara Valley Open Space Authority in 1994 as an Office Manager; and

WHEREAS, Luz returned to the Public Health Department in 1999 as a Secretary II/ACE and then became an Administrative Support Officer managing department-wide facilities; and

WHEREAS, Luz served from 2019-2021 as the Logistics Chief at the Public Health Departmental Operations Center during the COVID-19 pandemic, where she oversaw the difficult work of our operations and infrastructure support teams; and

WHEREAS, Luz was promoted to an Administrative Services Manager II in 2022 where she oversaw 23 locations for facilities-related work, technology infrastructure, office maintenance, and operational areas and handled a variety of other responsibilities; and

WHEREAS, Luz's unique expertise, ability to get things done, and relentless efforts have played a lasting role in building the Public Health Department's administrative and physical infrastructure; and

WHEREAS, Luz is known for her exceptional work ethic, ability to establish and maintain relationships to achieve a high level of customer service, and unique ability to solve complex administrative and operational issues; and

WHEREAS, Luz's ability to successfully accomplish department-wide goals, notwithstanding funding and resource constraints, is nothing short of heroic; and

WHEREAS, Luz played a pivotal supporting role in nearly every emergency activation of the Public Health Department's emergency operations for over 20 years, including activations for Y2K, meningitis, H1N1 influenza, hepatitis A, COVID-19, and mpox; and


WHEREAS, Luz's three and a half decades of service stand as a testament to her strong commitment to public health, leaving a lasting mark on our infrastructure and organization.
