This agreement is entered into between SOURCEWISE and **COUNTY OF SANTA CLARA**

CONTRACT TERM: October 01, 2022 - September 30, 2024 until terminated, canceled or amended

The parties mutually agree to this amendment in the following particulars and no others. All actions noted below are by reference made part of the Agreement and incorporated herein:

Congregate Meals	100,000 units of service; 400 unduplicated persons	Title III C-1 Federal American Rescue Plan Act (ARPA) [Older Americans Act], P.L. 117-2	\$1,543,378

Title III C-1, Congregate Meal services award increase from one time only funding from \$1,341,407 to \$1,543,378. Service units were not increased and remain at 100,000 units of service. Unduplicated persons were not increased and remain at 400 unduplicated persons.

In the agreement, the below terms and conditions are amended:

Section 1: Scope of Work:

The CONTRACTOR is responsible for carrying out the terms of this AGREEMENT, including the satisfaction, settlement, and resolution of all administrative, programmatic, and fiscal aspects of the program(s), including issues that arise out of any subcontracts, and shall not delegate or contract these responsibilities to any other entity. This includes, but is not limited to, disputes, claims, protests of award, or other matters of a contractual nature. The AREA AGENCY decision on these matters is final, however the CONTRACTOR of the AREA AGENCY may appeal the AREA AGENCY final adverse determination relating to Title III and Title VII programs using the appeals process established in 22 CCR 7700 to 7710.

Section 2: Levine Act Compliance:

AREA AGENCY will comply and will ensure that its agents (as that term is defined under 2 Cal. Code Regs. § 18438.3(a)) comply, with California Government Code section 84308 ("Levine Act") and the applicable regulations of the Fair Political Practices Commission concerning campaign disclosure (2 California Code of Regulations sections 18438.1 – 18438.8), which (1) require a party to a proceeding involving a contract to disclose on the record of the proceeding any contribution, as defined by Government Code section 84308(a)(6), of more than \$250 that the party or their agent has made within the prior 12 months, and (2) prohibit a party to a proceeding involving a contract from making a contribution, as defined by Government Code section

84308(a)(6), of more than \$250 to any COUNTY officer during the proceeding and for 12 months following the final decision in the proceeding. AREA AGENCY agrees to submit required disclosures to be made under the

Levine Act at the Office of the Clerk of the Board of Supervisors website at <http://www.sccgov.org/levineact>. If this Contract is to be considered or voted upon by the COUNTY's Board of Supervisors, AREA AGENCY shall complete the Levine Act CONTRACTOR Form: Identification of Subcontractors and Agents, and AREA AGENCY must submit all such forms to the County as a prerequisite to execution of the Contract.

The validity of all terms and conditions not expressly amended by this Amendment remain unaffected. The undersigned, as authorized representatives of **COUNTY OF SANTA CLARA** and SOURCEWISE respectively, certify the establishment of this Amendment to the Contract.
