**RESOLUTION OF THE BOARD OF SUPERVISORS  
OF THE COUNTY OF SANTA CLARA  
DELEGATING CONTRACTING AUTHORITY TO  
IMPLEMENT THE MASTER CONTRACT LIST  
FOR FISCAL YEAR 2024-25**

**WHEREAS**, the Board of Supervisors (“Board”) of the County of Santa Clara (“County”) will approve a Budget for FY 2024-25 in compliance with State law in the coming months;

**WHEREAS**, in order to provide the County programs, services, and activities contemplated in the proposed Budget, it is necessary and desirable for the County to contract for certain services;

**WHEREAS**, the Board desires to streamline this contracting process to the extent feasible, while retaining appropriate oversight and controls, and ensuring compliance with legal requirements and the County’s contracting policies; and

**WHEREAS**, delegating authority to the County Executive, or designee, to negotiate and execute contracts and agreements (“agreements”) as part of the County’s budget implementation process is appropriate, considering the multiple contractual arrangements required to facilitate the provision of these programs, services and activities, and the need for expeditious and timely provision of contracted services.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of the County of Santa Clara, State of California, as follows:

1. Delegated Authority to Enter into Expenditure Agreements. The Board hereby authorizes and delegates authority to the County Executive, or designee, to negotiate, execute, and terminate expenditure agreements or amendments to existing agreements, and any subsequent amendments thereto, as described in Exhibit A, which is attached hereto and incorporated herein by this reference, and subject to all of the requirements described in this Resolution. The delegation amount for the expenditure agreement or amendment listed in Exhibit A must not exceed \$5,000,000. The expenditure agreement or amendment listed in Exhibit A must also not increase the total maximum financial obligation of the existing agreement by more than the total of the projected value of the FY2024-25 agreement or amendment listed in Exhibit A plus a contingency that does not exceed 10% of that amount. Any subsequent amendments must not: (1) extend the contract term beyond the dates listed in paragraph 4 A. below, or (2) expand the scope of services.
2. Delegated Authority for Grant Agreements. The Board hereby authorizes and delegates authority to the County Executive, or designee, to submit grant

applications described in Exhibit A and to negotiate and execute the resulting grant agreement, any necessary amendments thereto, and any documents that are directly related to receiving the grant, provided the agreement is consistent with the authority extended by this Resolution. For grant agreements, the Requested Delegation Amount listed in Exhibit A may be increased provided the cumulative value of the amendments per year does not exceed \$5,000,000. Any subsequent amendments must not: (1) extend the contract term beyond the dates listed in paragraph 4 B. below, or (2) expand the scope of services.

3. Delegated Authority for Revenue Agreements. The Board hereby authorizes and delegates authority to the County Executive, or designee, to negotiate, execute, and terminate revenue agreements as identified in Exhibit A, any necessary amendments thereto, and any documents that are directly related to amending the revenue agreement, provided the agreement is consistent with the authority extended by this Resolution. For revenue agreements, the Requested Delegation Amount listed in Exhibit A may be increased provided the cumulative value of the amendments per year does not exceed \$5,000,000. Any subsequent amendments must not: (1) extend the contract term beyond the dates listed in paragraph 4 B. below, or (2) expand the scope of services.
4. Duration of Delegation and Agreement Term. Exhibit A specifies the duration of the delegation for each agreement and amendment submitted under the MCL and must be consistent with the dates listed below.

A. For expenditures agreements, the duration of the delegation shall not be longer than twelve months, starting no earlier than July 1, 2024 and no later than June 30, 2025. In no case may the agreement term extend beyond twelve months, ending no later than June 30, 2026.

B. For grant or revenue agreements, the duration of the delegation shall not be longer than five years, starting no earlier than July 1, 2024 and no later than June 30, 2029. In no case must the agreement term extend beyond five years, ending no later than June 30, 2029.

5. Delegation of Authority to Provide Interim Agreement Extensions. The Board intends to provide continuity of programs, services, and activities while agreements authorized by this Resolution are negotiated and executed. For any agreements the Board directs be removed from Exhibit A as originally presented to the Board on May 7, 2024, the County Executive, or designee, is authorized to extend the term of that agreement with the same party for the same services up to and including September 30, 2024, if applicable, absent Board direction to the contrary.
6. County Counsel and County Executive Approval: Compliance with Contracting Policies. Prior to execution by the County Executive or designee, all agreements and amendments listed in Exhibit A are subject to approval as to form and legality by the Office of the County Counsel, and shall conform to all Board contracting policies, unless otherwise specifically approved by the Board. Prior to execution

by the County Executive or designee, all agreements and amendments listed in Exhibit A are also subject to approval by the Office of Budget and Analysis. All contracts, including amendments and renewals listed in Exhibit A must also conform to Board policy.

7. Copies to Clerk of the Board. The County Executive and/or designee granted authority to negotiate and execute an agreement or amendment pursuant to this Resolution shall provide a PDF copy of the executed agreement or amendment to the Clerk of the Board within 30 days of execution, together with a copy of the Delegation of Authority Cover Sheet. The department or agency shall designate a specific location for all original copies of the agreement or other subsequent amendments in the department.
8. Budgeted Amount; Authority to Encumber Funds. The County Executive, or designee, is authorized to encumber the approved requisite funds for the agreement or amendment listed in Exhibit A.
