Incumbent AssetWorks (used for 20+years) has provided frequent updates and its performance has met all requirements. This Solicitation/RFP will enable FAF to determine if it wants to remain on that platform the incumbent AssetWorks provides or to another platform / solution / vendor that better meets its needs. Fleet Management uses AssetWorks Fleet Maintenance Software for cost tracking, fuel tracking, repair tracking, maintenance scheduling and history, parts inventory, tire management, vehicle information, warranty tracking, and work order management. It is a critical part of Fleet as it is the system of record for all work performed on the many vehicles that Fleet maintains.
