

# *Enterprise Medical Staff Credentials Recommendations*

**Thursday, March 28, 2024**

The Enterprise Credentials Committee and the Interdisciplinary Practice and Credentials Committee recommended the listed practitioners to the Enterprise Medical Executive Committee of the Hospitals (Santa Clara Valley Medical Center (SCVMC), O'Connor Hospital (OCH), and St. Louise Regional Hospital (SLRH)) for review and recommendation of initial appointment, reappointment, clinical privileges, additional clinical privileges, advancement and/or change in membership status, and Primary and Secondary designations. Based upon review of education, training and experience, verifications of credentials, peer and performance evaluations; NPDB and sanctions reports, and/or other supporting information; the committees find these practitioners qualified and appropriate for membership to the medical staff with clinical privileges as delineated, including as applicable, Telehealth privileges. All newly privileged medical staff members shall be appointed to a provisional status for at least 12 months and privileges subject to a Focused Professional Practice Evaluation (FPPE).
