SUBJECT: Enterprise Medical Executive Committee Report

RECOMMENDED ACTION

Approve appointments/reappointments and privileging actions of specified medical staff and allied health professional at Santa Clara Valley Medical Center, O'Connor Hospital, and St. Louise Regional Hospital as outlined on the Credentials Report dated March 28, 2024. (LA-4)

REASONS FOR RECOMMENDATION

The Enterprise Medical Executive Committee (EMEC) is required by State and Federal regulations, The Joint Commission standards and the Medical Staff Bylaws and Rules to review and make recommendations to the Governing Body for granting of initial appointment, reappointment, clinical privileges, advancement and/or change in status for practitioners at Santa Clara Valley Medical Center (SCVMC), O'Connor Hospital (OCH) and St. Louise Regional Hospital (SLRH).

The EMEC has reviewed the applications and credentials of the medical staff and allied health professionals who are specified in the attached Enterprise Medical Staff Credentials Recommendations Report to the Governing Board dated March 28, 2024 ("Report") and recommends them for approval for appointment, reappointment, clinical privileges, and/or change in the status as specified on the attached Report.

In addition to the recommendations for appointment, reappointment, clinical privileges, and/or change in status, the Report shows physicians who have designated their Primary Hospital site and their Secondary Hospital site pursuant to the Secondary Site Approval and Onboarding Process Enterprise Policy #0001.

BACKGROUND

The Enterprise Medical Executive Committee in accordance with State and Federal regulations, The Joint Commission standards and the Medical Staff Bylaws and Rules makes monthly recommendations to the Governing Body for appointment, reappointment, clinical privileges, and/or change in status for medical staff and allied health professionals. The appointments are for a period no longer than 24 months. The Report specifies those practitioners who are being submitted this month for approval, and those practitioners who are resigning or withdrawing their clinical privileges and medical staff membership. The Report (dated March 28, 2024) includes all practitioners who were submitted this month for approval, as well as those practitioners who are resigning or withdrawing their clinical privileges and medical staff membership.

On December 15, 2020, the Board of Supervisors delegated authority to the Health and Hospital Committee (“Committee”) to act on medical staff appointments and reappointments. However, the Board of Supervisors retains the ultimate responsibility, and may act on delegated matters where the Committee does not. The Committee did not take action on the March 28, 2024 Credentials Report, and thus the EMEC is requesting action by the full Board of Supervisors.
