All traffic approaching this intersection from Lavender Lane shall come to a complete stop before entering the intersection.




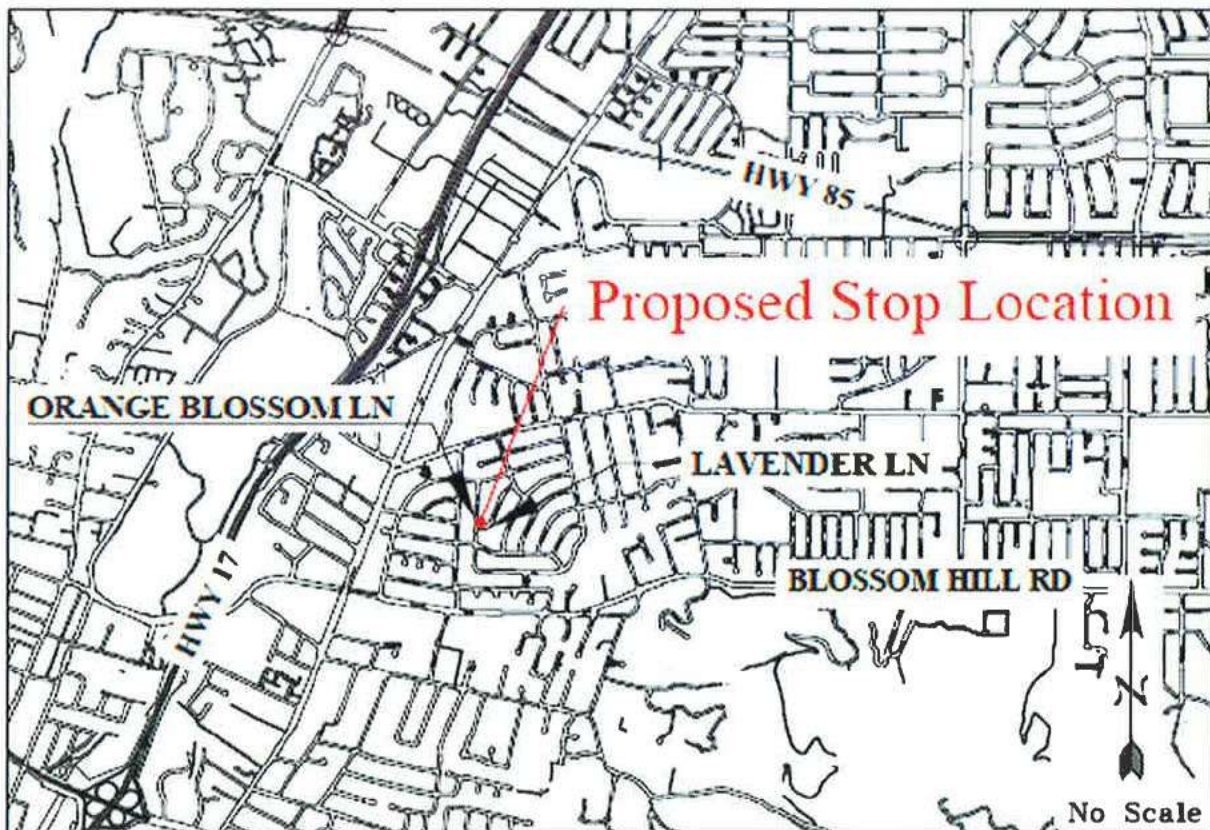

**RECOMMENDED ACTION**

Adopt Resolution establishing one-way stop control for intersection of Lavender Lane with Orange Blossom Lane.

**FISCAL IMPLICATIONS**

There is no fiscal impact to the General Fund. Sufficient funds are available in Fiscal Year 2023-2024 Road Fund account 0023-4001-5280000 (Special Department Expense) to install the necessary signage, striping, and markings. Department Staff will perform the work.

**CONTRACT HISTORY**

None.

**REASONS FOR RECOMMENDATION AND BACKGROUND**

Lavender Lane and Orange Blossom Lane are both two-lane roads in the unincorporated area of the Town of Los Gatos. The existing T-intersection of Lavender Lane and Orange Blossom Lane is currently uncontrolled.

Based on a stop sign warrant study, traffic engineering analysis and site observations, County staff recommends the Board of Supervisors adopt a resolution establishing one-way stop control for the Lavender Lane approach to Orange Blossom Lane. The recommended stop control will provide more orderly traffic flow through this intersection.

**CHILD IMPACT**

The recommended action will have a positive impact on children and youth for the **Every Child Safe** indicator by providing for orderly traffic flow through the Lavender Lane and Orange Blossom Lane intersection.

## **SENIOR IMPACT**

The recommended traffic action will provide for orderly flow of traffic through the Lavender Lane and Orange Blossom Lane intersection, positively impacting all roadway users including seniors.
