Dear Board President Susan Ellenberg (District 4), Supervisor Sylvia Arenas (District 1), Supervisor Cindy Chavez (District 2), Supervisor Otto Lee (District 3), and Supervisor Joe Simitian (District 5):

Each year, thousands of Asian, Asian American, and Pacific Islander residents across Santa Clara County join in Lunar New Year festivities marking the end of winter and ushering in the start of spring. Celebrated as far back as 3,500 years ago, the Lunar New Year – also referred to as the Spring Festival – is a way to honor one's ancestors and bless harvests at the turn of the year. Many Asian countries such as China, Vietnam, Korea and others, now celebrate Lunar New Year as a weeklong vacation holiday permitting many to travel back home to visit with their family.

As a county that prides itself on recognizing, equitably investing in, and living out its values of diversity, equity, and inclusion, it is important to continue to embrace and protect a culture's long held customs and traditions. In doing so, we are able to promote greater cultural acceptance rooted in mutual compassion, empathy, and understanding for one another. Still reeling from the negative effects of anti-Asian and Asian American racial animus and prejudice in a post-COVID 19 world, designating Lunar New Year as an official county holiday ensures we set the course bending the arc toward justice. And there is local precedent. The San Francisco Unified School District, the City College of San Francisco, the Santa Clara Valley Water District, and even the State of California through Assembly Bill 2596 (Low) have all approved and implemented Lunar New Year as a holiday in one form or another. With an estimated 41.4% Asian, Asian American and Pacific Islander resident population, it is time the County of Santa Clara does too.

It is for these reasons, and more, that I am in full support of Supervisor Otto Lee's Board Referral Agenda Item #31 relating to options for consideration on the viability and costs associated with declaring Lunar New Year a County holiday.

Dear President Ellenberg and Members of the Board of Supervisors,

On behalf of Asian Americans for Community Involvement (AACI), I am writing to urge the Board of Supervisors to approve Supervisor Lee's referral to the Administration with options for consideration regarding the viability and costs associated with declaring Lunar New Year a County Holiday.

AACI is a community-based nonprofit organization that primarily offers health, behavioral health, and wellness services to low-income communities and communities of color in Santa Clara County. As an organization founded in 1973 to address the unmet needs of Southeast Asian refugees resettled in the area, we recognize the importance of culturally specific holidays as a means of celebrating the richness and diversity of Silicon Valley. Lunar New Year is one such holiday, widely celebrated by Chinese, Vietnamese, and Korean communities, and is particularly significant amongst Asian Americans. The Holiday is also popular among various local organizations and groups that host annual events, bringing together many community members in celebration.

In Santa Clara County, Asian Americans account for 41.4% of the population. As of January 2024, nearly a third of the County's 24,000+ employees (coded and Extra Help) identify as Asian American or Pacific Islander. An official recognition by the County of Lunar New Year would help acknowledge the diversity and cultural significance that the Asian American and Pacific Islander community brings to Santa Clara County, similar to the County's holiday observances for Martin Luther King, Jr. Day, Cesar Chavez Day, and Juneteenth. A possible commemoration of the Lunar New Year as an official County holiday would be especially meaningful considering recent waves of hatred and violence toward Asian Americans that have escalated since the onset of the COVID-19 pandemic.



My name is Alyssa. I'm a nurse at VMC and on the RNPA board.

I wish to bring to your attention two important issues.

First, I am in support of Supervisor Lee's referral of Lunar New Year holiday to honor the Asian people of our community. I have noticed since my family has immigrated from Vietnam to this valley that this community has been thriving over the last 40 - 50 years. The Asian community is an intricate part of this society. It would be a prestigious recognition to celebrate this lunar new year of health, prosperity, peace for all as an official holiday.

Secondly, I wish to bring to your attention the need for reform of the timekeeping and payroll system for hospital staff. Nurses often wait many pay periods to many months for a correction to their paychecks. This is money owed to them for hours they have already worked. Not only is this not fair, but it's wrong. Timekeeping staff make up their own interpretation of our MOU and it's not consistent across departments or hospitals. Some nurses get paid for differentials. However, others working the same shift, but under a different timekeeper may not. Please help us get paid what we should. This isn't asking for more, it's only asking for what is correct and in a timely manner.







**RECOMMENDED ACTION**

Approve referral to Administration to report to the Board on May 7, 2024 with options for consideration relating to the viability and costs associated with declaring Lunar New Year a County holiday. (Lee)

**FISCAL IMPLICATIONS**

The financial costs associated with this referral are currently unknown since County Administration has not implemented Lunar New Year as an official holiday.

**REASONS FOR RECOMMENDATION**

Lunar New Year is one of the most important holidays in China, Vietnam, South Korea and one of the most widely celebrated among Asian Americans. This holiday is also a popular one among local organizations and groups that host annual events, bringing together many community members in celebration.

In Santa Clara County, Asian Americans account for 41.4% of the population. As of January 2024, nearly a third of the County's 24,000+ employees (coded and Extra Help) identify as Asian American or Pacific Islander.

An official recognition by the County of Lunar New Year would help acknowledge the diversity and cultural significance that the Asian American and Pacific Islander community brings to Santa Clara County, similar to the County's holiday observances for Martin Luther King, Jr. Day, Cesar Chavez Day and Juneteenth. A possible commemoration of Lunar New Year as an official County holiday would be especially meaningful considering recent waves of hatred and violence toward Asian Americans that has escalated since the onset of the COVID-19 pandemic.

**BACKGROUND**

Other municipalities in California, including the state itself, have made strides in officially recognizing Lunar New Year in their respective jurisdictions:

- In 2006, the San Francisco Unified School District Board of Trustees approved a

resolution that made the holiday an annual event even if the Lunar New Year falls on a weekend.

- City College of San Francisco observes Lunar New Year as a day off for the college community. California education code specifies the holidays that community colleges can celebrate, and the two required days in February are Lincoln Day and Washington Day, are usually combined into a single holiday (Presidents' Day). This holiday thus frees up a day for another celebration, and the college has opted to celebrate Presidents Day and the Lunar New Year. Locally, the San Jose-Evergreen Community College District has added Lunar New Year as an official district holiday.
- In 2022, Governor Gavin Newsom signed AB 2596 (Low), declaring Lunar New Year to be a state holiday. But the designation in California is largely symbolic because the law as enacted didn't make the holiday a paid day off for state employees. Employees of the state can only use eight hours of vacation, annual leave, or compensating time off in lieu of receiving eight hours of personal holiday credit to observe the Lunar New Year.
- Last year, Assemblymember Phil Ting and City College of San Francisco Board of Trustees President Alan Wong announced a bill that would give community colleges the option to make Lunar New Year a state holiday. AB 264 would give students the opportunity to celebrate Lunar New Year without missing class. The bill offers community colleges the flexibility to observe Lunar New Year as a state holiday without increasing the number of days schools are closed. This means that community colleges could come up with solutions like combining Lincoln's and Washington's birthdays into one holiday and adding Lunar New Year as another holiday. Governor Newsom signed AB 264 into law.
- Similarly, the Santa Clara Valley Water District Board unanimously voted to recognize Lunar New Year as a paid holiday. Staff also recommended that Valley Water provide each employee one extra vacation day to be added to each employee's vacation balance in lieu of not receiving the holiday that year for Fiscal Year 2023 in observance of Lunar New Year.

In 2020, the Board of Supervisors unanimously passed a resolution proclaiming June 19 of each year as Juneteenth Day and a County holiday. Juneteenth Day commemorates and marks the effective end of slavery in the United States on June 19, 1865, almost two and one-half years after President Lincoln issued the Emancipation Proclamation. The additional cost of implementing a holiday was estimated to be approximately \$2.3 million and subjected to change depending on staffing required and assignments made by operating departments on a given holiday.
