

FISCAL IMPLICATIONS

There is no impact to the General Fund because of this action.

REASONS FOR RECOMMENDATION

Construction is complete and the project has passed final inspection and received Department of Health Care Access and Information approval. The next step is for the Board of Supervisors (Board) to accept the work, which will allow retention to be released, the one-year period warranty to start, and the project to be closed.

Background

On May 24, 2022, Item No. 38, the Board approved SCVMC Women and Children's Center - 5th Floor Library & Improvement Project and authorized advertisement of the contract documents.

On September 13, 2022, Item No. 70, the Board awarded the Construction Contract for Project No. 263-CP23020 “SCVMC Women and Children's Center - 5th Floor Library & Improvement” in the amount of \$2,380,000 to California Plus Engineering, Inc, with a construction time of 210 calendar days. An additional \$238,000 was encumbered as Supplemental Work Allowance for a total encumbered amount of \$2,618,000.


