CHANGE ORDER NO. 1

PROJECT TITLE: Mt. Madonna Fuel Reduction Project at Mt. Madonna County Park

CONTRACTOR:	Anvil Builders, Inc.

TERMS AND CONDITIONS OF CHANGE:

1. Contractor is hereby directed to make the changes set forth below. By its signature on this Change Order, Contractor agrees that the net change in the Contract Amount stipulated below shall constitute full compensation, accord and satisfaction for all costs and requests for costs associated with the changed work, including labor, material, and equipment costs, rescheduling, overhead, profit, and any other costs arising directly or indirectly from the changed work, including without limitation, delay, and disruption. Contractor certifies the net adjustment in the Contract Amount reflects costs of labor, equipment, and materials, including all markups, and has been calculated in conformance with the applicable modification procedures.
2. Contractor agrees that the additional contract time allotted (if any) is sufficient, and that there shall be no further time extensions or delay claims resulting from this Change Order.
3. Contractor approves the changes herein, and the Contract Amount specified for each item and the extension of time allowed, if any, for completion of the entire Work as stated herein, and agrees to furnish all labor, materials, and service, and perform all work necessary to complete any additional work specified for the consideration stated herein. Submission of sums which have no basis in fact or which Contractor knows are false are at the sole risk of Contractor and may be a violation of the False Claims Act set forth under Government Code section 12650 et seq.
4. Contractor understands that no additional compensation shall be allowed for costs associated with this Change Order. It is expressly understood that the value of the extra work or changes identified herein expressly includes any and all of the Contractor's costs, expenses, field overhead, home office overhead, and profit, both direct and indirect, resulting from additional time required on the Project or resulting from delay to the Project. Any costs, expenses, damages, or time extensions not included are deemed waived.
5. Except as provided herein, all terms and conditions of the underlying contract referenced herein, shall remain unchanged and are in full force and effect.
6. This Change Order shall not be effective until signed by the County's authorized representative.

DESCRIPTION OF WORK TO BE PERFORMED:

Contractor to provide all labor, materials, and equipment necessary to:

1. Remove additional two (2) Eucalyptus trees along the Shaded Fuel Break along Pole Line Road as indicated on the attached plans. Contractor shall process the additional trees in the same treatment prescription as directed in the specifications. Contractor shall treat the stumps with approved herbicide in the same treatment prescription as directed in the specifications.
(reference PCO #2) \$11,560.65

2. Remove additional thirty-nine (39) Eucalyptus trees at the Inspiration Point removal units as indicated on the attached plans. Contractor shall process the additional trees in the same treatment prescription as directed in the specifications. Contractor shall treat the stumps with approved herbicide in the same treatment prescription as directed in the specifications.
(reference PCO #2) \$168,197.08

3. Remove additional forty-six (46) non-Eucalyptus dead and snagged trees along the Shaded Fuel Break along Pole Line Road as indicated on the attached plans. Contractor shall process the additional trees in the same treatment prescription as directed in the specifications.
(reference PCO #2) \$191,240.05

By reason of this change, the overall Contract Time is increased by **30 calendar days**, which extends the substantial completion date of Inspiration Point Work to: 5/17/2024, the substantial completion date of the entire Work to: 6/14/2024, and the final completion date to: 7/14/2024.



¹ California Code of Regulations section 18438.3 states:

(a) A person is the ‘agent’ of a party to, or a participant in, a pending proceeding involving a license, permit or other entitlement for use only if the person represents that party or participant for compensation and appears before or otherwise communicates with the governmental agency for the purpose of influencing the pending proceeding.

(b) If an individual acting as an agent is also acting as an employee or member of a law, architectural, engineering or consulting firm, or a similar entity or corporation, both the entity or corporation and the individual are “agents.”

(c) “Communication with the governmental agency for the purpose of influencing the proceeding” does not include:

(1) Drawings or submissions of an architectural, engineering, or similar nature prepared by a person for a client to submit in a proceeding before the agency if:

(A) The work is performed pursuant to the person's profession; and

RECOMMENDED ACTION

Approve Contract Change Order No. 1 - Interim - for the Mt. Madonna Fuel Reduction Project at Mt. Madonna County Park, Contract No. 23-17. Contractor - Anvil Builders, Inc. Net increase of \$370,998, an increase of 30 calendar days, and no change in Supplemental Work Allowance. (LA-1)

FISCAL IMPLICATIONS

There is no impact to the County General Fund as a result of the recommended action.

The cost of Contract Change Order No. 1 shall utilize the Supplemental Work Allowance already approved by the Board of Supervisors. Additional funding for Contract Change Order No. 1 beyond the Supplemental Work Allowance is included in the Parks and Recreation Department's Fiscal Year 2023-2024 Adopted Budget for forest health management.

CONTRACT HISTORY

On June 27, 2023, the Board of Supervisors (Item No. 142) awarded a contract to Anvil Builders, Inc. (the "Contractor", formerly Kingsborough Atlas Tree Surgery, Inc.) in the amount of \$657,059, which included a Supplemental Work Allowance of \$65,706, for a total encumbered amount of \$722,765, and a construction time of three hundred (300) calendar days. The contract was executed on August 8, 2023, and a Notice to Proceed for construction was issued on August 12, 2023.

REASONS FOR RECOMMENDATION AND BACKGROUND

Reasons to Approve Contract Change Order

The original scope of work included removal of approximately 21-acres of highly flammable blue gum eucalyptus in two locations within Mt. Madonna County Park and the establishment of a 2-mile long Shaded Fuel Break along Pole Line Road. The plans and specifications were developed by a Registered Professional Forester in collaboration with Parks and Recreation Department (the "Department") staff.

After the award of contract and project commencement, additional eucalyptus trees outside of the limit of work and hazardous dead and dying trees along Pole Line Road were discovered. The extent of the invasive and dead hazard trees was not accounted for in the original scope and duration of the project contract. Removal of these trees will be most efficiently addressed during this contract period. Including the additional removals will further reduce the risk of wildfire by effectively removing all eucalyptus in the area and conserve funding by not having to rebid or remobilize a contractor to perform the work.

Department staff negotiated the value of these additional scope items consistent with the pricing submitted by the Contractor in their Schedule of Values submitted during pre-construction. The County is receiving fair value for the cost of the work in the Change Order.

Mt. Madonna Fuel Reduction Project

The Mt. Madonna Fuel Reduction Project (the “Project”) is in the process of implementing two top-priority forest management and wildfire risk reduction projects identified in the 2018 Mt. Madonna Forest Health Plan (the “Plan”). The Plan was developed to address high rates of tree mortality due to drought stress and soil pathogens, resulting high fuels loads, and encroachment of highly flammable non-native trees in the forests of Mt. Madonna County Park. The Plan and its CEQA determination were adopted by the Board of Supervisors on February 26, 2019 (Item No. 69).

In March 2020, the County accepted \$828,574 of California Climate Investments (CCI) Grant funds through the CALFIRE Fire Prevention Grant Program. Since the award of the grant funds, the Department has conducted public outreach on the Project through demonstration projects, education programs and outreach to tribal organizations, park visitors and other stakeholders and has completed project planning and development of project specifications. As part of the grant award, the Department has coordinated with CALFIRE for the implementation of these wildfire prevention actions. Additionally, the Department has coordinated this and other projects with the Santa Clara County Fire Safe Council to improve emergency egress for mountain communities.

CHILD IMPACT

The recommended action will have a positive impact on children and youth through the **Healthy Lifestyle** indicator as the Project will reduce the risk of catastrophic wildfire in a forest used by numerous youth groups and residents. Improvement of forest conditions will ensure that future generations will enjoy the ecological benefits of a high-quality redwood forest, oak woodlands, and mountain meadows and the health benefits afforded by such natural open spaces.

SENIOR IMPACT

The recommended action will have a positive impact on seniors as the Project will improve forest conditions and reduce the risk of intense wildfire that could require temporary but long-lasting closure of public lands.

SUSTAINABILITY IMPLICATIONS

The recommended action will have a positive impact on sustainability by improving forest

health and ensuring the duration of ecosystem services such as carbon sequestration, wildlife habitat and watershed functions.

CONSEQUENCES OF NEGATIVE ACTION

Forest conditions would not be improved at Mt. Madonna County Park and accumulations of dead and dying vegetation and invasive eucalyptus would not be removed. The risk of catastrophic wildfire would continue to rise.
