**RESOLUTION OF THE BOARD OF SUPERVISORS

APPROVING DONATION AGREEMENT WITH THE NEW  
ALMADEN QUICKSILVER COUNTY PARK ASSOCIATION**

**WHEREAS**, the New Almaden Quicksilver County Park Association (“NAQCPA”) has offered to donate to the County of Santa Clara (“County”), for use in Almaden Quicksilver County Park (the “Park”) Casa Grande and New Almaden Quicksilver Mining Museum (the “Museum”), historical assets as listed in the Donation Agreement (the “Agreement”) between the County and NAQCPA (each a “Party” and collectively, “Parties”);

**WHEREAS**, the County’s Department of Parks and Recreation (“Department”) desires to receive the historical assets in the Agreement, the value of which is estimated to exceed ten thousand dollars (\$10,000), to advance the Department’s strategic goals of offering innovative and engaging visitor services and interpretive programming, and protecting significant County historical and cultural resources;

**WHEREAS**, County Ordinance Code section A2-17 and County Board of Supervisors Policy Manual section 7.15.1(B) require that donations to the Department valued at ten thousand dollars (\$10,000) or more be formally accepted, recognized, and approved by the Board of Supervisors as trustee for the County before being received; and

**DONATION AGREEMENT BY AND BETWEEN THE COUNTY OF SANTA CLARA  
AND THE NEW ALMADEN QUICKSILVER COUNTY PARK ASSOCIATION**

This New Almaden Quicksilver County Park Association Donation Agreement ("Agreement"), effective as of the date last signed below, is entered into by and between the County of Santa Clara, a political subdivision of the State of California, ("County") and the New Almaden Quicksilver County Park Association, ("NAQCPA") a 501(c)(3) nonprofit organization. County and NAQCPA are each a "Party" and collectively the "Parties" to this Agreement.

**WHEREAS**, NAQCPA owns the historical assets listed in Exhibits A, B, and C (collectively, the "Assets");

**WHEREAS**, County owns and operates Casa Grande and the New Almaden Quicksilver Mining Museum (the "Museum") within Almaden Quicksilver County Park (the "Park");

**WHEREAS**, County has the necessary rights and authorizations to store, display, and use the Assets at the Museum and Park;

**WHEREAS**, donating certain of the Assets to the County serves NAQCPA's mission of historic preservation and promoting the educational and interpretative activities of the County Parks and Recreation Department, particularly in Almaden Quicksilver County Park;

**WHEREAS**, NAQCPA desires to donate certain of the Assets to the County, and County desires to accept those Assets, under the terms and conditions hereinafter set forth; and,

**WHEREAS**, NAQCPA desires to continue storing other Assets at the Museum under County control and wishes to waive its right to compensation for any associated losses.

**NOW, THEREFORE**, the Parties agree to the foregoing and as follows:

1. **Donation.** NAQCPA agrees to donate the assets listed in Exhibits A and B (collectively, the "Donation Assets") to County and grant County irrevocable ownership, rights, title, and interest in the Donation Assets upon the terms and conditions set forth in this Agreement and without monetary payment to NAQCPA, and the Board of Supervisors agrees to approve and accept such donation on behalf of the County pursuant to County of Santa Clara Ordinance Code section A2-17. The Donation Assets will be transferred to County free and clear of any liens, claims, or encumbrances. NAQCPA shall maintain ownership rights over the assets listed in Exhibit C.
2. **Transfer of Ownership.** Ownership and risk of loss as to each Donation Asset transfers to County upon execution of this Agreement.
3. **Right of First Refusal.** Before any of the Donation Assets is sold or otherwise transferred by the County at any time following the effective date of this agreement (including transfer by gift or operation of law), County shall notify NAQCPA and provide NAQCPA or its assignee(s) with a right of first refusal to receive the Donation Asset(s) by transfer from

the County. Should NAQCPA decline to exercise its right of first refusal within ninety (90) days of receiving notice from County regarding the desired transfer, County may transfer the Donation Asset(s) at its discretion.

4. **Indemnification.** Notwithstanding any other provision of this Agreement, NAQCPA shall indemnify, release, hold harmless, and defend, with counsel approved by County, County and its officers, agents, and employees from any claim, demand, suit, judgment, liability, loss, injury, damage, or expense of any kind (including attorneys' fees and costs) arising out of, or in connection with, performance of this Agreement by NAQCPA and/or its officers, agents, employees, or sub-contractors, excepting only loss, injury, or damage caused by the sole negligence or willful misconduct of personnel employed by County. It is the intent of the parties to this Agreement to provide the broadest possible coverage for County as allowed by law. NAQCPA shall reimburse County for all costs, attorneys' fees, expenses, and liabilities incurred with respect to any litigation or process in which NAQCPA contests its obligation to indemnify, defend, and/or hold harmless County under this Agreement and does not prevail in that contest.
5. **Warranty Disclaimer.** THE ASSETS ARE DONATED "AS IS" WITH ALL FAULTS. NAQCPA MAKES NO WARRANTY WHATSOEVER, EXPRESS OR IMPLIED, WITH RESPECT TO THE ASSETS, INCLUDING ANY WARRANTY OF CONDITION, QUALITY, OR SUITABILITY, WARRANTY OF MERCHANTABILITY, WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE, OR WARRANTY OF TITLE, WHETHER EXPRESS OR IMPLIED BY LAW, COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE OF TRADE, OR OTHERWISE.
6. **Notices.** Any notice required to be given by either Party, or which either Party may wish to give, shall be conducted through email as a primary means of communication, using the email addresses specified below:

Notice shall be deemed effective on the date emailed, personally delivered or, if mailed, three (3) days after deposit in the mail. Either Party may designate a different person and/or address for the receipt of notices by sending written notice to the other Party.

7. Severability. If any term or provision of this Agreement is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction. Upon such determination that any term or other provision is invalid, illegal, or unenforceable, the Parties shall negotiate in good faith to modify this Agreement so as to effect the original intent of the Parties as closely as possible in a mutually acceptable manner in order that the transactions contemplated hereby be consummated as originally contemplated to the greatest extent possible.
8. Amendment and Modification. This Agreement may be amended, modified, or supplemented only by an agreement in writing signed by each Party hereto.
9. Governing Law, Venue. This Agreement has been executed and delivered in, and shall be construed and enforced in accordance with, the laws of the State of California. Proper venue for legal action regarding this Agreement shall be in the County of Santa Clara.
10. Third Party Beneficiaries. This Agreement does not, and is not intended to, confer any rights or remedies upon any person or entity other than the parties.
11. Authority. The person(s) signing this Agreement on behalf of NAQCPA represents and warrants to County that they have the requisite legal authority and power to execute it, and to bind NAQCPA to the obligations contained herein.
12. Counterparts and Contract Execution. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same Agreement. Unless otherwise prohibited by law or County policy, the Parties agree that an electronic copy of a signed contract, or an electronically signed contract, has the same force and legal effect as a contract executed with an original ink signature. The term "electronic copy of a signed contract" refers to a transmission by facsimile, electronic mail, or other electronic means of a copy of an original signed contract in a portable document format. The term "electronically signed contract" means a contract that is executed by applying an electronic signature using technology approved by the County.
