WHEREAS, the City of Palo Alto Junior Museum and Zoo and the nonprofit Friends of the Junior Museum and Zoo are receiving the 2024 Tall Tree “Outstanding Nonprofit” Award, an award that annually honors organizations exemplifying outstanding service to the Palo Alto community;

WHEREAS, established in 1934, the City of Palo Alto Junior Museum and Zoo is celebrating its 90th anniversary in 2024 and is known as one of our region’s largest providers of quality standards-based science education;

WHEREAS, the nonprofit Friends of the Junior Museum and Zoo has played a key partnership role in the success of the facility, most recently providing significant funding for a project in 2021 that doubled the size of the zoo, added new classrooms, expanded zoo capacity to include more than 50 animal species, and added a two-story, wheelchair accessible treehouse that visitors can climb to get an overview of the zoo’s landscapes;

WHEREAS, the City of Palo Alto Junior Museum and Zoo serves approximately 184,000 children and adults annually through hands-on science exhibits and interactive animal experiences, engaging every visitor’s curiosity in science and nature while continuing to promote inclusion in its programming; and,

WHEREAS, the City of Palo Alto Junior Museum and Zoo is a community treasure.
