- WHEREAS,** Betsy served on the Foothill-De Anza Community College District Board of Directors between 2003 and 2016, during which she served as Vice-President and President, and served on the Board of Directors of the Foothill-De Anza Foundation, during which she was chair of two district measures that raised millions for campus developments;
- WHEREAS,** Betsy has volunteered in leadership roles on the boards of numerous local organizations, including the Committee for Green Foothills, YMCA of the Mid-Peninsula, the Palo Alto and Los Altos Chambers of Commerce, and the Palo Alto chapter of the League of Women Voters, has served as President of the Rotary Club of Palo Alto, and in 1992 was awarded the first Palo Alto Chamber of Commerce Athena Award and a national Athena Award in recognition of her service and accomplishments; and
